BASIC UNIT WARRANTY (PARTS AND LABOR)

Within the warranty period stated above, Carrier Transicold Division, Carrier Corporation ("Carrier Transicold") through designated Dealers shall, during normal working hours, repair or replace with a new or remanufactured part, any parts or components of the products identified above which UNDER NORMAL USE AND SERVICE malfunction as a result of defects material or workmanship. This warranty does not include scheduled maintenance items or transportation costs to and from the dealer's facility. Scheduled maintenance items include, but are not necessarily restricted to the following: engine oil, grease and lubricants, fuel, filters and filter elements, and cleaning materials. Batteries are excluded from this warranty (batteries are warranted by the battery manufacturer).

In the event warranty repairs are performed outside the boundaries of the United States of America, Carrier Transicold is not responsible for any duties, taxes, or associated charges as may be applicable in accordance with the regulations of the country where such warranty repair is performed.

This warranty does not apply to any equipment which in Carrier Transicold's sole judgment has been subjected to misuse, negligence in handling or accident, operated contrary to manufacturer's printed instructions, or has been so repaired or altered as to adversely affect its operational integrity. This warranty extends only to the original owner of the equipment.

MAJOR COMPONENTS

The warranty, including parts and labor, is extended to the period given in the matrix for:

- Engine: All internal diesel engine parts and head gasket. Excluded engine parts are seals, gaskets, water pump, starter motor, coolant thermostat, glow plugs and filters. The optional Carrier Engine Emissions System is detailed in a separate warranty statement.
- Engine Emission Control System: Intake and exhaust manifolds, fuel injectors, injector lines and fuel injection pump.
- Heater Coil / Radiator
- Fan Shaft Assembly
- Main Microprocessor Module: Module excluding external wiring.
- Display Module: Module excluding external wiring.

THE FOREGOING WARRANTIES ARE EXPRESSLY GIVEN IN LIEU OF ANY OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE WHICH ARE HEREBY DISCLAIMED.

LIMITATION OF LIABILITY

CARRIER TRANSICOLD AND ITS AFFILIATES SHALL NOT BE LIABLE FOR ANY SPECIAL, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES. THE OWNER'S SOLE AND EXCLUSIVE REMEDY, AND CARRIER TRANSICOLD'S AND ITS AFFILIATES SOLE AND EXCLUSIVE LIABILITY, WHETHER FOUNDED IN STATUTE, CONTRACT, TORT (INCLUDING STRICT LIABILITY AND NEGLIGENCE) OR ANY OTHER THEORY OF LIABILITY, SHALL BE LIMITED TO THE REPAIR OR REPLACEMENT OF PARTS OR COMPONENTS IDENTIFIED ABOVE, SUBJECT TO THE LIMITATIONS STATED HEREIN.

THIS WARRANTY IS VOID UNLESS:

- a. Installation of unit is in accordance with Carrier Transicold installation drawings
- b. Date in service is recorded on unit serial plate
- c. Unit must be registered with Carrier Transicold (except as otherwise prohibited by law)
